Picture the scene. You are supposed to be attending a sales conference in Crewe when you are woken from your slumber by the ring tone from your company-issue mobile phone. 'I'm here now,' you lie to your boss from the comfort of your hotel bed, safe in the knowledge that she will never know otherwise.

5 But, alas, your mobile phone uses a new technology which means your boss can pinpoint your exact location.

It is the stuff of slackers' nightmares. But 'location-based tracking' – to use the mobile phone industry's terminology – is about to become reality.

10 Mobile-phone networks will soon be able to pinpoint the precise location of a handset owner to within 10 meters or less. From the middle of next year many phones will carry Global Satellite Positioning chips, while another new technology, known as 'Triangulation' can pinpoint a mobile-phone user's whereabouts.

15 The concept has already been warmly embraced by a number of firms. 'It's popular with fleet and logistics firms who want to know where their lorries are,' said Julie Ramage of mobile-phone consultancy Analysys.

But the move has sparked huge controversy among civil liberty groups who fear that mobile-phone companies will be able to play Big Brother.

'It's a very worrying development. The scope for the misuse of this technology is enormous,' said Barry Hugill, spokesman for the civil rights group Liberty.

20 At the heart of the issue is who should be allowed to track a mobile phone. 'If you have a mobile phone, your network operator must know where you are in order to provide a service. The issue is whether they make that information available to third parties,' Ramage said. 'That information cannot just be used by anybody. People have to sign up to have the information shared.'

25 Some experts are worried that firms might make it a condition of an employee's job specification that they give their consent for their phone to be tracked.
